The Personal Data we Collect, and Why

When signing up to our mailing list, we ask that you give us your name and email address so that we can keep in touch with you, sending occasional updates and newsletter content. Typically this will be no more than once per month.

We rely on your consent (which, under GDPR, is the legal basis conveniently known as 'Consent') to send you these emails, and you can opt-out at any time. The easiest way to do this is by clicking on the unsubscribe link at the bottom of our emails, but you can contact us at any time to do this.

We store this information in a system called Hubspot - here's a [link](#) to their privacy policy - and this data is therefore based in Republic of Ireland (EEA)

We keep your name and email address for 2 years before checking in with you to see if you still want to receive our emails. If you don't, we'll delete your data from our emailing system.

We also collect some information about the use of this website via cookies, which means that we process your IP address.

The website is developed using the [Webflow](#) platform and uses the following cookies:

Your rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.
